Social and cultural norms around the world normalise sexual and gender-based violence. Excuses are made for perpetrators, while victims are blamed for their own assaults.

Through **Conversations on Consent** (CoC) we get people to speak about consent to foster a new norm based on empathy for one another.

## **Defining Consent** in Sexual Criminal Law

This comprehensive model consent law was put together based on the research and a number of workshops held by the Legal Expert Council.

To ensure bodily and sexual autonomy, integrity, and wellbeing consent must be obtained through honest, respectful, genuine, and open communication. The defendant has a responsibility to ensure there is consent. Consent must be obtained for each sexual act between the parties and can be withdrawn at any time. It must also be obtained for sexual activity in the digital realm to ensure the right to privacy, confidentiality, and non-defamation. It must be informed, voluntary, free without monetary compensation, retractable and unequivocal. Consent can only be given when one has capacity.

It will be assumed that consent can neither be obtained nor given in the context of power imbalance in terms of access to networks, resources and/or knowledge, unless the defendant proves otherwise. Such contexts include any form of inequality between the parties, including, but not limited to, inequality of access or liberties to any means, resulting or potentially resulting in any legal, economic, social, or other vulnerabilities.

The defendant can never obtain consent through threats, force or other forms of coercion, abduction, fraud, deception, abuse of power or a position of vulnerability or dependency. Consent cannot be obtained through insistence, manipulation, emotional threats, blackmail, or making the victim feel guilty for an action and presenting sexual behaviour as a way of compensation. Within this context, coercion is defined as intimidation, compulsion, domination, or control. Deception or false pretence may include – but is not limited to – evoking, taking advantage of, and failing to correct the victim's misunderstanding about the defendant's identity or situation, or the nature of the act.

It will be assumed that consent cannot be given tacitly through noncommunication or inactivity. It cannot be given by someone who is unable to exercise free will, including a condition which prevents the giving of consent such as being in a state of unconsciousness, intoxication, sleep, illness, bodily injury, or under duress or distress. Everyone has the right to exercise their free will, bodily and mental integrity, autonomy, and self-determination, irrespective of sexual orientation, gender identity, gender expression or sex characteristics.


#### **Eithne Dowds**

#### **Queen's University Belfast**

Dr Eithne Dowds is a Senior Lecturer in the Law School at Queen's University Belfast. Her research focuses on the legal construction of the crime of rape, with a particular focus on formulations of sexual consent, in international and domestic criminal law. Her monograph, Feminist Engagement with International Criminal Law

(Hart 2019) explored the relationship between consent and coercion as elements of the crime of rape. More recently, her work has focused on the trend towards the adoption of affirmative notions of consent, as well as legal framings of the accused's mindset in respect of consent. Eithne has an interest in the law and procedure surrounding the prosecution of sexual offences more generally, co-editing a collection of papers on reform efforts in the context of Northern Ireland (Killean, Dowds and McAlinden, Sexual Offences on Trial, 2021).

Thordis Elva's violence prevention work towards gender-equality earned her the title Woman of the Year in 2015. As a speaker, she has delivered keynotes at events hosted by the UN, the Nordic Council of Ministers, the Council of Europe, the European Union and the Nordic Council.



## **Jonathan Herring**

#### **Oxford University**

Jonathan Herring is a Professor of Law at the University of Oxford and the DW Wolfe-Clarendon Fellow in Law at Exeter College, University of Oxford. He works in Criminal Law, Family Law and Medical Law and Ethics, focussing particularly on how the law regulates love, care and intimacy.

His books include Domestic Abuse and Human Rights, which is a powerful call to understand domestic abuse as a breach of human rights and Rough Sex and the Criminal Law (with Hannah Bows) which explores the killing of women during alleged 'rough sex'. A survivor of image-based abuse herself, Alena started the petition #NotYourPorn to demand better regulation of adult content platforms, improvements to German criminal law and

additional resources for victim support structures. The petition reached >180,000 signatures, got picked up by the European Parliament and partially integrated into the draft text of the Digital Services Act. In addition, Alena consults NGOs and UN organizations on the topic of data governance and cyber violence.






#### **Emily Setty** University of Surrey
